**Price Range:** Most items are price \$10-\$15. Some brochures offer one price pricing.

**Number of Pages:** 1-page to 20-page brochures.

**Number of items:** Varies by brochure and range from 12-80 items in each brochure.

**Recommended for:** Groups of 10 or more

**Minimum Order:** 50 items (that's just 10 people selling 5 items)

## Pricing and Profit

Organizations can earn up to 50% profit\* with Poppin Popcorn brochures. Retail prices range from \$8-\$32 with most items selling for \$10-\$15. Organizations will pay 50% of the retail selling price with 200 items sold

Non-tax exempt organizations are able to report their own tax. We will email an invoice only for the amount due for the cost of the products and shipping if sales are less than \$50.00.

### How does the program work?

- **Choose the brochure you want to offer your supporters.**
- ~ **Review the enclosed Sales Agreement**, complete, and fax, scan, or mail to our office. You can also submit your sales agreement electronically on our website. There's no wait to receive brochures! You'll receive your brochures within 4-5 days.
- ~ We'll provide the documents you'll need including a sample cover letter you can modify, a master order form if you are submitting your order as a bulk order. With 100 participant orders we can pack-by-seller. Pack-by-seller orders require additional time to allow for shipping the order forms to us and for completing the data entry.
- ~ Determine if your organization is tax exempt. You do not have to submit your tax exemption certificate to our office but you are encouraged to assure you are state tax exempt before proceeding with your fundraiser. If you are not exempt you have the option to collect tax and report your sales.
- ~ **Distribute brochures to your sellers** and determine how long you will continue your sales. (Most organizations sell for 2 weeks) We encourage closing on a Monday rather than a Friday to allow your participants to sell over the weekend. Customer checks, if accepted, are made payable to your organization.
- ~ **Collect all brochures and payments at the end of your selling period.** We ask for a minimum of 50 items to submit an order. Otherwise, a fee will be required to cover the cost of providing the brochures plus shipping. If you are submitting an order to be packed-by-seller, assure they are readable and the amount of money collected is correct. Mail a copy of your order forms to Deb Murray, 102 Thompson St, South Glastonbury, CT 06073. Once we receive your Master Order Form or your student order forms for a packed-by-seller order we will email an invoice to you with the total amount due. You'll keep your profit upfront.
- ~ **Shipping is FREE with just 50 items sold!** Orders less than 200 items will add \$20 shipping.
- ~ **Brochure Fee:** Brochures are shipped with no upfront cost. We do require 1 item on average to be sold for each brochure shipped to cover the costs. Otherwise, a nominal fee for the shortage will be charged. Rarely, is a brochure fee required.
- ~ **We will email an Invoice** for the amount due.
- ~ **Pay for your purchase.** Payment by school/organization check, money order, cashier's or certified check is required. **Purchase Orders and payment by credit cards are not accepted** for Poppin Popcorn orders. W-9s and vendor applications are provided as needed.
- ~ **A confirmation will be emailed to you** once we receive payment. Once payment has been received, your order will be submitted to our shipping department for processing.
- ~ **Report any missing or broken items.** Seldom are there any missing or broken items with our shipments. However, should any corrections be required, return the check-in form within 48 hours and we will process a new order for the replacements.
- ~ **We'll provide coaching to help your campaign succeed,** extended office hours Mon-Sun 9am-9pm EST, and a solid commitment to process your order and needed replacements with no delay. When you require help, we'll be available to help you!

**Profit:** Sell 200+ items: 50% Profit, Sell 100-199 items: 40% Profit, Sell 50-99 items: 35% Profit.

**Product Displays/Late Orders:** Regular pricing applies. For an order with less than 50 items, 35% discount applies plus \$20 shipping.

**Tax Exemption:** Organizations who are tax exempt are responsible for determining their state tax exemption status. Organizations who are not state tax exempt will be responsible for reporting state tax to their appropriate state. Non-exempt organizations may collect the tax.

**Shipping:** Shipping is free on all orders \$200 or greater in retail sales. Orders less than \$200 will add a \$20.00 shipping fee. Orders are generally shipped within 2 weeks upon receipt of payment and are generally shipped via FedEx. Large orders are shipped by freight carrier with an arranged delivery.

**Brochures:** We ship brochures at no upfront cost to your organization but we do request enough items are sold to cover costs. A fee is added to an invoice only if the total number of items sold is less than the total number of brochures shipped. The fee is calculated only on the shortage. For example, order 100 brochures, sell only 70 items. A fee is added for just 30 brochures.

**Payments:** Customer checks are made payable to your organization. Acceptable forms of payment include Money Order, Business, or School Check. **Personal checks, temporary checks, checks with hand-written group/business names, electronic credit cards, and purchase orders are not accepted.** Payments by check/money order must be paid in full prior to the order being placed. Returned check fee is \$50.00.

**Missing Items:** Report any missing items within 48 hours following delivery. Send an email with the name of the item, how many were received, and the number missing. Organization will be responsible for the accuracy of the total number of items sold and ordered.

**Sales Agreement:** **MUST be returned to Deb Murray prior to distributing your brochures.** I have read, understand and agree with the terms and conditions listed above and have received approval from my organization (school principal, board members etc.) to sign on behalf of my organization.
